

Version 8.2 Update Guide

About This Update

This update is primarily for the rate changes that take effect on January 2, 2012 for the following carriers:

- DHL
- FedEx
- UPS
- Lone Star Overnight

You can run this update at any time. If you run this update before Sunday, January 1, optionally you can load the new rates early; beginning January 1 the rate load process will begin automatically. See page 2 for details.

IMPORTANT! Updating directly from Version 8.0 If you skipped updating to Version 8.1 and are updating directly from Version 8.0, there are many important new services and features that were introduced in Version 8.1. Instructions



Run the Update

This will update your system **from Version 8.0 or 8.1 to Version 8.2.** After downloading the Version 8.2 update file from the PC Synergy website* to your Windows desktop, follow these steps. PostalMate network users: Every station must be updated one at a time, starting with the Master.

- 1. Do a PostalMate backup.
- 2. Close all programs on all workstations.
- **3.** Double-click on the downloaded file.* This will extract the necessary files and initiate the update.
- 4. Follow the steps in the install wizard until complete.
- * If updating from a CD, insert the CD. When the menu appears, click on "Update to Version 8.2"

 step Load and set new rates 1. After running the update, new Published rates need to be loaded for each carrier. Your options will depend on when you run the update.

2. When prompted for each carrier, click **OK** to load the published rates.

What's New in Version 8.2

This section contains a summary of the major changes and enhancements included in Version 8.2.

Carrier rate changes

This update supports the rate and business rule changes for the carriers listed below, effective on Monday, January 2, 2012. Here's a quick summary of the primary changes:

DHL. Rates increase for all services. In addition:

- DHL's assumed liability coverage is now based on weight, rather than the industry's standard model of "the first \$100 is free." The basis is \$11.34 per pound. So, for a 10-pound package, DHL would provide \$113.40 of coverage (\$11.34 x 10 pounds) at no additional charge; for a 5-pound package the amount would be \$56.70.
- Additional coverage (Shipment Value Protection) increases from \$.80 to \$.85 per \$100. Your retail rate is percentage-based, so it will increase automatically. The minimum charge increases from \$2.75 to \$2.90.
- PostalMate now supports DHL's Security Services surcharge, which adds 10% for high-risk destinations (currently it applies only to Afghanistan and Iraq). This is a "pass-through" surcharge in PostalMate, and cannot be marked up.

FedEx. Rates increase for all Express and Ground services. In addition:

- For Ground, there's a change to how packages are rated when the dim weight exceeds 150 pounds. Essentially, the 150-pound wholesale rate is divided by 150 to arrive at a per-pound rate, which is then multiplied by the dim weight. PostalMate applies the same calculation to the retail rate.
- The minimum charge for Declared Value above \$100 increases from \$2.25 to \$2.40.
- "Extended Area Surcharge" (for international) is renamed "Out-of-Delivery Area."

United Parcel Service. Rates increase for all services. In addition:

- The DAS Residential surcharge now has different rates for Air and Ground services.
- The Residential Canada surcharge now has different rates for Air and Standard.
- The minimum charge for Declared Value above \$100 increases from \$2.25 to \$2.40.



- Lone Star Overnight. Rates increase for all services. In addition:
 - Service names have been changed: "Priority Basic" is now "Priority Overnight;" "Priority Early" is now "Early Overnight;" and "Priority Economy" is now "Economy Next Day."
 - Declared Value coverage over \$100 increases from \$.75 to \$.80 per \$100. The minimum charge for Declared Value above \$100 increases from \$2.25 to \$2.40.
